

Privacy and Management Information

The privacy policy relating to the data management of the service available at www.endo-kapszula.com and on the website is continuously available on the referenced website.

Endo-Kapszula Kft., Hereinafter referred to as the data controller, acknowledges the content of this statement as binding on itself, but reserves the right to change the statement, provided that it notifies the interested parties of the changes in due time.

The data controller attaches great importance to respecting the right of its customers to self-determination of information. It treats personal data confidentially and takes all measures to ensure the security of the data.

Data management principles:

Personal data can be processed if

- (a) the data subject consents (voluntarily), or
- b) it is ordered by law or its authorization by a local government decree for a purpose based on the public interest (mandatory).

Personal data may be transferred and the various data processing operations may be combined if the data subject has consented to it or is permitted by law and if the conditions for data processing are met for each personal data.

Personal data may only be processed for a specific purpose, in order to exercise a specific right and fulfill an obligation.

Only personal data that is necessary for the realization of the purpose of data processing and is suitable for the achievement of the purpose may be processed only to the extent and for the time necessary for the realization of the purpose. Voluntary personal data may only be processed with informed consent.

The data subject shall be informed in a clear, comprehensible and detailed manner of all facts relating to the processing of his data, in particular the purpose and legal basis of the processing, the data subject, the duration of the processing and who may have access to the data. The information shall also cover the data subject's rights and remedies in relation to the processing.

The use of a general and unique identification mark that can be used without restriction is prohibited.

Personal data processed

- (a) be recruited and treated fairly and lawfully;
- (b) be accurate, complete and, where necessary, timely;
- (c) be stored in such a way that the data subject can be identified only for the time necessary for the purpose of storage.

The transfer of data to the EEA States shall be deemed to take place within the territory of Hungary. Personal data may be transferred to a controller or processor in a third country if the data subject has expressly consented to it or is permitted by law, and an adequate level of protection of personal data is ensured during the handling or processing of the transferred data in the third country.

Scope of personal data

Data management is based on voluntary consent.

We inform the informants that if they do not provide their own personal data, the informant is obliged to obtain the consent of the data subject.

The range of data managed: username, password, first and last name, e-mail addresses,

telephone numbers, company name, date and time of registration.

Deadline for deleting data: ten years from the last registration, and for withdrawals for sending the newsletter until the consent is withdrawn. The accounting documents are kept for 8 years pursuant to Section 169 (2) of Act C of 2000 on Accounting.

What are cookies and how do we handle them?

Cookies are small data files ("cookies") that are transmitted to your computer via a website using a website that is saved and stored by your internet browser. Most of the most commonly used Internet browsers (Chrome, Firefox, etc.) accept and allow the download and use of cookies by default, but it is up to you to refuse or disable them by changing your browser settings, or to delete cookies already stored on your computer. can delete. Acceptance of cookies is not obligatory, however, Endo-Kapszula Kft. Does not take any responsibility if, in the absence of enabling cookies, our website may not function as expected.

The data controller will delete the received letters, together with the name and e-mail address of the sender and other personal data provided voluntarily, up to five years after the handling of the case.

The way personal data is stored, the security of data management

Data management related to the visit to the website

Endo-Kapszula Kft. Does not need to provide personal data to view the information published on the website www.endo-kapszula.com. Endo-Kapszula Kft. Automatically receives the following data about the visitors of the websites: the IP address of the visitor, the date of the visit, the subpages and contents viewed on the website.

This data is displayed in Google Analytics due to automatic data transmission. Endo-Kapszula Kft. Uses this data exclusively for the analysis of the website and for checking the secure operation of the website.

The way personal data is stored, the security of data management

The computer systems and other data storage locations of the website can be found at the headquarters of the data controller.

Endo-Kapszula Kft. Selects and operates the IT tools used for the management of personal data during the provision of its services in such a way that the managed data:

- (a) accessible to those entitled to it (availability);
- b) its authenticity and authentication are ensured (authenticity of data management);
- (c) its integrity can be demonstrated (data integrity);
- (d) be protected against unauthorized access (data confidentiality).

Endo-Kapszula Kft. Ensures the protection of the security of data management with technical, organizational and organizational measures that provide a level of protection appropriate to the risks arising in connection with data management.

Endo-Kapszula Kft. Retains it during data management

(a) confidentiality: the information shall be protected so that only those who have access to it may have access to it;

(b) integrity: protects the accuracy and completeness of the information and the method of processing;

(c) availability: ensuring that, when the authorized user needs it, he has effective access to the information required and that the means to do so are available.

The IT system and network of Endo-Kapszula Kft. The operator ensures security with server-level and application-level protection procedures.

We inform users that electronic messages transmitted over the Internet, regardless of protocol (e-mail, web, ftp, etc.), are vulnerable to network threats that lead to unfair activity, contract disputes, or the disclosure or modification of information. To protect against such threats, the service provider will take all precautionary measures required of it. It monitors the systems to record any security incidents and provide evidence of any security incidents. System monitoring also allows you to check the effectiveness of the precautions taken.

Remedies

The data subject may request information on the processing of his or her personal data, as well as the rectification of his or her personal data, or, with the exception of data processing required by law, as indicated in the data collection.

At the request of the data subject, the controller shall provide information on the data processed by the processor or the data controller, the purpose, legal basis, duration of the data processing, the name, address (registered office) and activities related to the data processing, and who and for what purpose they receive or have received the data. The data controller shall provide the information in writing in a comprehensible form as soon as possible after the submission of the request, but no later than within 30 days. This information shall be free of charge if the person requesting the information has not yet submitted a request for information on the same area to the controller in the current year. In other cases, Endo-Kapszula Kft.

Endo-Kapszula Kft. Deletes personal data if its processing is illegal, the data subject requests it, the purpose of data processing has ceased or the term for storing data specified by law has expired, it has been ordered by a court or the National Data Protection and Freedom of Information Authority.

Endo-Kapszula Kft. Notifies the data subject of the rectification and deletion, as well as all those to whom the data was previously transmitted for the purpose of data management. It shall refrain from notification if this does not harm the legitimate interests of the data subject with regard to the purposes for which the data are processed. The data subject may object to the processing of his or her personal data if

(a) the processing (transfer) of personal data is necessary solely for the purpose of enforcing the right or legitimate interest of the controller or the recipient of the data, unless the processing is required by law;

(b) personal data are used or transmitted for the purposes of direct business acquisition, public opinion polling or scientific research;

c) the exercise of the right to protest is otherwise permitted by law.

Endo-Kapszula Kft. - with the simultaneous suspension of data processing - will examine the protest within the shortest time from the submission of the application, but not later than within 15 days, and will inform the applicant in writing of the result. If the protest is justified, the controller shall terminate the processing, including further data collection and transmission, and block the data, as well as notify all persons to whom the protested personal data have previously been transmitted and who have taken action against them. are obliged to take measures to enforce the right to protest.

If the data subject does not agree with the decision of the data controller, he or she may appeal against it to the court within 30 days of its notification.

Endo-Kapszula Kft. May not delete the data of the data subject if the data processing has been ordered by law. However, the data may not be transferred to the data recipient if the data controller has agreed to the protest or the court has established the legitimacy of the protest.

If the data subject's rights are violated, he or she may take legal action against the data controller. The court is acting out of turn in the case.

Endo-Kapszula Kft. Will indemnify the damage caused to others by the illegal handling of the data of the data subject or by violating the requirements of technical data protection. The data controller shall be released from liability if the damage was caused by an unavoidable cause outside the scope of data processing.

It does not compensate for the damage if it was caused by the injured party's intentional or grossly negligent conduct.
